

As of November 1st, 2024, recipients of Deferred Action for Childhood Arrivals (DACA) can apply for health insurance through Covered California and receive financial help to lower their monthly premium payments. DACA recipients are eligible to enroll during open enrollment from Nov. 1 through Jan. 31 and begin using their health plan the first day of the following month after submitting their application and selecting a plan.

Covered California has developed this toolkit which contains information, resources, and tools that can be used to educate consumers about this new change and how to enroll.
