- Board Certification as a Psychiatric Mental Health Nurse Practitioner from the American Nurses Credentialing Center (ANCC) is preferred but not required.
- Currently licensed by the state of CA Board of Registered Nursing as a Registered Nurse.
- Currently certified by the State of CA as a Nurse Practitioner.
- Two years clinical experience as a Registered Nurse, with a minimum of one year of experience in the clinical area assigned. Experiences must have been as a Registered Nurse within a United States Licensing Jurisdiction.
- Must have or be eligible to receive a California state-issued medication Furnishing Number and United States Drug Enforcement Administration (DEA) number upon completion of appropriate training.
- Current Cardio-Pulmonary Resuscitation certification, in compliance with corporate CPR policy.
- Fluency in English (speaks, read and write).
- Fluency in Spanish (speak, translate, read and write) preferred
