Participates with Director-level managers in the planning, implementation, and on-going evaluation of the quality and effectiveness of client care and support services Will oversee, coordinate, develop and evaluate the programs' overall effectiveness to ensure its consistency with the Agency's Mission, Vision and Values. Ensure compliance with Federal, State and County statutes and regulations. Provide direct patients a between 60-80% of FTE
