Clinical care amounts to approximately 50% and the remaining 50% is administrative and supervisory responsibilities.

- Participate in the overall development and directions of the Clinical Program.

- On call after hour's service as well as coordinate with other specialties such as Psychiatry.

 information from the UM/QM Committees to both the Board of Directors and the
 provider network.
- Participates in the evolution and refinement of the Quality improvement process as well as other committees such as Senior Management, Emergency Preparedness.
- Completes special projects as deemed necessary by the CEO.
