## Summary:

The primary care physician, using standardized procedures, elicits patient's medical and social history, performs review of systems, initiates lab/radiological tests and studies, provides health tracking and counseling, monitors and manages chronic conditions, provides care to patients experiencing homelessness in a healthcare for the homeless clinic as well as providing care in a mobile clinic and in street outreach, charts findings, exercises independent judgment in the management/delivery of service in accordance with established NEVHC, LARFPC, CHDP, MCH, CPSP, and other regulatory agency guidelines.

## **Qualifications:**

- 1. For primary care physician, must be a graduate of an accredited medical school with a valid, current CA Medical license to practice and have completed a training program at an accredited institution with certification as licensed physician in the disciplines of family medicine or internal medicine.
- 2. Must maintain a current Cardio-Pulmonary Resuscitation certification, in compliance with corporate CPR policy.
- 3. Must demonstrate through written practice and/or oral testing, the knowledge and skills necessary to provide care appropriate to the age of the patients served and has knowledge of the principles of growth and development over the life span. He or she is able to identify and categorize each patient's age specific grouping of needs, such as those for infant, adolescent, adult or geriatric patients.
- 4. Fluency in English (speaks, read and write).
- 5. Fluency in Spanish (speak, translate, read and write) is desired.
- 6. Prefer experience (cultural competence) working with vulnerable populations and clients with mental illness and substance use disorder.
- 7. Prefer a candidate familiar with the area community resources for individuals experiencing homelessness.
