Our services include medical, dental, optometry, behavioral health, radiology, ultrasound, mammography, laboratory, pharmacy, and health education. We are accredited by The Joint Commission for ambulatory services and certified as a Primary Care Medical Home. We serve as a clinical training center for medical students and nurse practitioners through our affiliation with local universities.

Job Description

The OB/GYN will provide medical care to women, including examine, diagnose, prevent and treat, illness, and disease. The OB/GYN provides care related to pregnancy and the reproductive system, explains diagnosis, procedures and discusses test results on prescribed treatments with patient, advises patients concerning diet, activity, hygiene, and disease prevention. The OB/GYN also specializes in childbirth, treating and counseling women throughout their pregnancy, from giving prenatal diagnoses to delivery and postpartum care. The OB/GYN will collaborate with other physicians and mid-level providers. The OB/GYN will perform other job related duties as required by departmental needs and demands.
