Job Description

The Licensed Clinical Social Worker (LCSW) will assess patients' psychosocial status as it relates to substance abuse and mental health, and communicate with physicians to report patient progress, needs, concerns, and potential and actual clinical issues. The LCSW will provide individual and group counseling to patients in a strengths-based, culturally sensitive linguistically appropriate, and compassionate manner. The LCSW will provide brief therapy implementing appropriate evidence-based practices and interventions in client sessions. The LCSW will establish a strong rapport with patients. The LCSW will prepare and maintain all pertinent records, statistics, and progress notes in a time-sensitive manner. The LCSW will work closely with all members of the health care team in the development of treatment plans, based on counseling assessment and social work interventions. The LCSW will partner with the Behavioral Health Case Manager to refer patients to appropriate specialty services and community agencies as appropriate. The LCSW will assist with ongoing clinical training, support, workshops, and inservices to Agency staff as needed.
